No Refunds issued on Quarterly Permit sales. Pro-rated refund less discount issued on Annual permits upon return of sticker & card(s).

Permit is valid in designated area(s) only, which are outlined on the information sheet to be included in the mailing with your permit sticker. Commuter permits are not valid at any metered parking areas. A site location map will be mailed with the permit. This is not a 24HR. parking permit; overnight parking is not permitted at any commuter areas during the hours of 2:00 AM to 5:00 AM. Vehicles parked during this time will be towed at the vehicle owners' risk and expense.

I understand that only one vehicle may be parked at any one time and that it is my responsibility to transfer the permit to an alternate vehicle, which must be listed above, along with having provided the registration for all vehicles must be submitted. I also understand that any and all notes in lieu of a valid permit will not be honored and that vehicles displaying altered or photocopied permits will be towed.

**I understand that my permit is NOT VALID at any designated Passport Parking Space.**

**I understand that my permit is NOT VALID on LEVEL 4 of the SITE F Garage.**

I understand that lost/damaged permit sticker and/or access card replacement requires an additional payment of \$10.00 each.

I, the undersigned, attest that I am currently a resident of the Unincorporated Town of Greenburgh. I hereby agree that

I will immediately surrender my permit and access card(s) at such time that I am no longer a resident of the Unincorporated Town of Greenburgh and/or discontinue renewal of my permit.
